

SNSports Terms of Service

Updated March 19, 2026

1. Overview

SNSports is a sports card consignment service that facilitates the auction sale of trading cards. By submitting cards to SNSports or using its services, you agree to these Terms of Service.

2. Auction & Listing Format

All cards are listed as auctions starting at **\$0.99**. Listings generally occur within **4–6 business days** after receipt. An **Express Upgrade** is available for cards expected to sell for **\$100 or more**, at a rate of **\$2 per card**, in addition to the standard **\$1 selling fee**. SNSports retains sole discretion over listing format and scheduling.

3. Zero-Bid Policy

Any card that receives no bids after being listed at a \$0.99 auction will become the property of SNSports and will not be returned. By submitting cards, consignors explicitly acknowledge and agree to this condition.

4. Non-Paying Buyers

If a buyer fails to pay within **7 days**, the item will be relisted at no additional charge to the consignor.

5. Payout Policy

SNSports aims to provide fast and transparent payouts.

Payout Timing: Payouts are issued within **3–5 business days** after funds clear, allowing time for potential payment issues or returns.

Default Method: ACH payment (recommended)

PayPal: Goods & Services only. The consignor is responsible for an additional **2.99% fee plus \$0.49**

6. Chargeback & Return Protection

Once payout has been issued, any return or chargeback will transfer ownership of the returned item to SNSports. The consignor is not required to return payout funds already issued.

7. Shipping & Insurance

SNSports is not responsible for items lost, stolen, or damaged in transit before delivery. Consignors are responsible for properly packaging and insuring their shipments.

8. Service Suitability

SNSports services are best suited for cards valued at **\$5 or more**. Low-value bulk submissions may be rejected.

9. Rejected Items

SNSports reserves the right to reject any submission. Return shipping costs may be paid by the consignor or deducted from sale proceeds.

10. Fees

A **\$1 per card selling fee** applies to all accepted cards. The Express Upgrade costs **\$2 per qualifying card**.

11. Limitation of Liability

SNSports is not liable for market fluctuations, auction results, platform outages, fraud, delays, grading variances, or other circumstances beyond its control.

12. Force Majeure

SNSports is not liable for delays or failure to perform caused by events beyond its reasonable control.

13. Governing Law

These Terms of Service are governed by the laws of the **State of Ohio**.

14. Modification of Terms

SNSports reserves the right to update or modify these Terms of Service at any time.

15. Right to Refuse Service

SNSports reserves the right to refuse service at its sole discretion.

16. Agreement

Submission of cards to SNSports constitutes acknowledgment and acceptance of these Terms of Service.
